# **Cross-jurisdictional Information** Exchange

+ Expedited information exchange and connection among jurisdictions by facilitating 179 jurisdictional information requests and 20 access requests. Produced quarterly publications on policing innovations and forensic sciences.

#### **Risk Management**

+ Mitigated legal risks to jurisdictions by facilitating 11 legal requests.

# **National Survey of Community** Satisfaction with Policing

+ Supported robust statistical analysis across policing agencies through facilitation of the contract for the National Survey of Community Satisfaction with Policing.

# **Forensic Capability Mapping**

+ Mapped and monitored cross-jurisdictional capability and determined minimum requirements for the firearms discipline to support forensic agencies' strategic planning at a cross-jurisdictional level.

# **Workflow Mapping Forensic Biology**

+ Mapped forensic biology workflows across Australia and New Zealand to identify opportunities for streamlining biology/DNA analysis processes to improve cost savings and reduce turnaround times.

# **Enhancing Practice**

+ Identified cross-jurisdictional collaboration opportunities aimed at enhancing forensic practices.

+ Continued to identify emerging issues to assist Australian and New Zealand Police to make more resilient decisions aided by AN7PAA Environment Scans.

+ Strengthened foresight capabilities to assist police to better plan for future events through the ANZPAA Futures and Strategic Foresight Toolkit.

#### **High Risk Response**

+ Provided contemporary guidance and information to support jurisdictional responses to, and management of, high risk situations through the review of Australia New Zealand Framework for Policing High Risk Situations.

# **Forensic Workshops**

+ Purchased over 500 proficiency tests in bulk and arranged controlled substances. agriculture and dangerous goods import permits, ensuring financial and administrative efficiencies.
